## **PRIVACY POLICY**

Awesome Admin (the “Company”) is committed to maintaining robust privacy protections for its users. Our Privacy Policy (“Privacy Policy”) is designed to help you understand how we collect, use and safeguard the information you provide to us and to assist you in making informed decisions when using our Service.

For purposes of this Agreement, “Site” refers to the Company’s website, which can be accessed at [www.awesomeadmin.online](http://www.awesomeadmin.online).

“Service” refers to the Company’s services accessed via the Site, in which users can book power hours or schedule discovery calls to receive business administration support and guidance.

The terms “we,” “us,” and “our” refer to the Company.

“You” refers to you, as a user of our Site or our Service.

By accessing our Site or our Service, you accept our Privacy Policy and Terms of Use (found here: [Terms of Use](#)), and you consent to our collection, storage, use and disclosure of your Personal Information as described in this Privacy Policy.

### **INFORMATION WE COLLECT**

Awesome Admin collects “Non-Personal Information” and “Personal Information” in the categories described below.

#### *Usage data*

Awesome Admin will process information about your use of our website and services (“usage data”). The usage data may include  
(1) the browser types and versions used

- (2) the operating system used by the accessing system
- (3) the website from which an accessing system reaches our website (so-called referrers)
- (4) the sub-websites
- (5) the date and time (so-called timestamp) of access to the Internet site
- (6) an Internet protocol address (IP address)
- (7) the Internet service provider (ISP) of the accessing system
- (8) the geographical location of the user
- (9) the page views and site navigation paths
- (10) the pattern of the users' use of the service with regards to timing and frequency
- (11) any other similar data and information that may be used in the event of attacks on our information technology systems.

The source of the usage data is Google Analytics. The usage data collected is needed to

- (1) deliver the content of our website correctly
- (2) optimise the content of our website as well as any advertisement
- (3) ensure the long-term viability of our information technology systems and website technology
- (4) provide law enforcement authorities with the information necessary for criminal prosecution in case of a cyber-attack.

In order to process this information, we have obtained the user's consent and our legitimate interests in monitoring and improving our website and services.

#### *Notification data*

Awesome Admin may process information that you provide to us for the purpose of subscribing to our email notifications and/or newsletters ("notification data"). Our newsletter may only be received by the user if

- (1) the user has a valid email address and
- (2) the user registers for the newsletter shipping.

A confirmation email will be sent to the email address registered by a user for the first time for newsletter shipping, for legal reasons, in a double opt-in procedure. The confirmation email is used to prove whether the owner of the email address as the user is authorised to receive the newsletter.

When the user registers for the newsletter, we also store the IP address of the computer system assigned by the Internet service provider (ISP) and used by the user at the time of the registration, as well as the date and time of the registration. The purpose of the collection of this data is to legally protect Awesome Admin by ensuring understanding of the possible misuse of the email address of a user at a later date. The personal information collected as part of a registration for the newsletter will only be used to send our newsletter.

The subscription to the newsletter may be terminated by the user at any time. The consent to the storage of personal data, which the user has given prior to the shipping of the newsletter, may be revoked at any time. For the purpose of revoking consent, a corresponding link for unsubscribing is found in each newsletter.

#### *Enquiry data, correspondence data and customer relationship data*

Awesome Admin may process information contained in any enquiry you submit to us regarding our services and products ("enquiry data"). If a user contacts us via email or via a contact form, the personal information transmitted by the user is automatically stored.

The personal information may include:

- (1) the user's contact information
- (2) the user's name
- (3) the name of the user's employer
- (4) the user's job title or role
- (5) the metadata associated with the communication
- (6) and information contained in communications between the user and Awesome Admin.

Such personal data transmitted on a voluntary basis by a user to Awesome Admin are stored for the purpose of processing or contacting the user, managing our relationships with customers, keeping records of communication with the user, and promoting our products and services to customers.

#### *Publication data*

Awesome Admin may process information that the users post for publication on our website or through our services ("publication data"). On our website the users can post information in the following ways:

Leaving comments on blog posts. Please note that any comments submitted through blog posts may be visible to other website visitors. Users are advised not to share sensitive personal information in public comments. All comments are subject to moderation and may be removed at our discretion.

#### *Transaction data*

Awesome Admin may process information that relates to transactions, including purchases of goods and services, that the user enters into with us and/or through our website ("transaction data"). The transaction data may include:

- (1) the user's contact details
- (2) payment and billing information securely via our third party payment provider
- (3) the transaction details with regards to the purchase

In order to process the transactions on our website we use the following third party payment services provider: Stripe. The details of how the user's data is processed by Stripe can be found here, <https://stripe.com/gb/privacy>.

We will share transaction data with our payment services providers only to the extent necessary for the purposes of processing your payments, refunding your payments and dealing with queries relating to your payments and refunds.

## **HOW WE USE AND SHARE INFORMATION**

### *Personal Information*

Except as otherwise stated in this Privacy Policy, we do not sell, trade, rent or otherwise share for marketing purposes your Personal Information with third parties without your consent. We do share Personal Information with vendors who are performing services for the Company, such as the servers for our email communications who are provided access to

the user's email address for purposes of sending emails from us. Those vendors use your Personal Information only at our direction and in accordance with our Privacy Policy.

In general, the Personal Information you provide to us is used to help us communicate with you. For example, we use Personal Information to contact users in response to questions, solicit feedback from users, provide technical support, and inform users about promotional offers.

#### *Non-Personal Information*

In general, we use Non-Personal Information to help us improve the Service and customise the user experience. We also aggregate Non-Personal Information in order to track trends and analyse use patterns on the Site. This Privacy Policy does not limit in any way our use or disclosure of Non-Personal Information and we reserve the right to use and disclose such Non-Personal Information to our partners, advertisers and other third parties at our discretion.

#### *Data controller and data processor responsibilities*

For the purposes of UK data protection law, Awesome Admin may act as either a data controller or a data processor depending on the nature of the services being provided. Where we collect and process personal information for our own business purposes, including enquiries, bookings, marketing activities, and client administration, Awesome Admin acts as the data controller.

Where we process personal information solely on behalf of a client as part of providing virtual assistant, bookkeeping, financial administration, inbox management, or related support services, Awesome Admin acts as a data processor and processes such data only in accordance with the client's instructions and applicable legal obligations.

#### *Legal purpose of the processing of personal data*

Awesome Admin may process any of your personal information identified in this privacy policy where necessary for the establishment, exercise or defence of legal claims, both in court proceedings and in an administrative or out-of-court procedure. The legal basis for this processing is the protection and assertion of our legal rights, your legal rights and the legal rights of others.

Awesome Admin may also process any of your personal information identified in this privacy policy where necessary for the purposes of obtaining or maintaining insurance coverage, managing risks, fulfilment of tax obligations, or obtaining professional advice. The legal basis for this processing is the proper protection of our business against risks.

### **DATA SECURITY**

Awesome Admin takes appropriate technical and organisational measures to help protect personal information against unauthorised access, loss, misuse, disclosure, alteration, or destruction.

These measures may include:

- (a) Password protected devices and accounts
- (b) Secure cloud based systems and software providers
- (c) Restricted access to personal information
- (d) Secure communication methods where appropriate

(e) Regular software and security updates

While we take reasonable steps to protect your personal information, no method of transmission over the internet or electronic storage is completely secure, and therefore we cannot guarantee absolute security.

## **RETAINING AND DELETING YOUR PERSONAL INFORMATION**

The personal information that we process for any purpose or purposes will not be kept for longer than is necessary for the expressed purpose. We will retain your personal data as follows:

- (a) Name, email address, and phone number (collected via the website, Calendly, or Google Forms) will be retained for a minimum of 1 day and a maximum of 30 days, unless you become a client. If it is confirmed that you will not be proceeding, your data will be deleted immediately.
- (b) Company name and website address (collected via onboarding forms) will be retained for a maximum of 30 days unless a working relationship begins.
- (c) Client personal data (such as contact details and relevant admin records) will be retained for the duration of our working relationship. Once our contract ends, all non-financial data will be securely deleted.
- (d) Financial records and invoicing data (including billing details collected via Stripe) will be retained for 7 years, as required by UK tax and accounting regulations.
- (e) Website usage data and IP addresses (collected via Google Analytics) will be retained in accordance with Google's own data retention policies and are used solely for analytical purposes.

In some instances, it is not possible for us to specify in advance the periods for which your personal information will be stored by us. In such cases, we will determine the period of retention based on the following criteria:

- (a) The period of retention of name, email address, phone number and enquiry data will be determined based on whether the enquiry leads to a working relationship. If it does not, the data will be securely deleted within 30 days.

## **YOUR DATA PROTECTION RIGHTS (GDPR and UK GDPR)**

If you are a resident of the EEA or the UK, you have the following data protection rights:

- If you wish to access, correct, update, or request deletion of your personal information, you can do so at any time by emailing [sue@awesomeadmin.online](mailto:sue@awesomeadmin.online).
- In addition, you can object to the processing of your personal information, ask us to restrict the processing of your personal information or request portability of your personal information.
- You have the right to opt-out of marketing communications we send you at any time. You can exercise this right by clicking on the "unsubscribe" or "opt-out" link in the marketing emails we send you. To opt-out of other forms of marketing, please contact us by emailing [sue@awesomeadmin.online](mailto:sue@awesomeadmin.online).
- Similarly, if we have collected and processed your personal information with your consent, then you can withdraw your consent at any time. Withdrawing your consent will not affect the lawfulness of any processing we conducted prior to your

withdrawal, nor will it affect the processing of your personal information conducted in reliance on lawful processing grounds other than consent.

- You have the right to complain to a data protection authority about our collection and use of your personal information. For more information, please contact your local data protection authority.

We respond to all requests we receive from individuals wishing to exercise their data protection rights in accordance with applicable data protection laws.

## **DATA PROTECTION COMPLAINTS**

Awesome Admin is committed to handling personal data responsibly and in accordance with applicable UK data protection laws.

If you have any concerns or complaints about how your personal data has been collected, used, stored, or handled by us, we encourage you to contact us in the first instance so that we can investigate and attempt to resolve the matter promptly.

Where necessary, we may contact you for further information in order to investigate your complaint fully.

We maintain an internal process for recording, investigating, and responding to data protection complaints in accordance with our legal obligations.

If you are not satisfied with our response, or you believe your data protection rights have been breached, you have the right to lodge a complaint with the Information Commissioner's Office (ICO).
